Treasurer's Report/Bill Payment of Bills – After review and discussion of the Treasurer's report and bill list, on motion of Deputy Mayor Port, seconded by Committeeman Orr to approve the Treasurer's report and the bills for payment in the amount of \$132,102.15, unanimously carried.

Mayor Reinhart called for a Public Hearing for Resolution No. 4-28-15, "Resolution Adopting the 2015 Municipal Budget of the Township of Greenwich". On motion of Committeeman Orr, seconded by Mayor Reinhart to open the public hearing, unanimously carried. Mr. Carluzzo questioned the funds for the convenience center. Ms. Lake indicated one amount was for the shared service agreement with Hopewell Township and the other amount was for the disposal cost which the township pays directly. There being no further public comment, on motion of Committeeman Orr, seconded by Deputy Mayor Port to close the public hearing, unanimously carried. On motion of Committeeman Orr, seconded by Deputy Mayor Port to approve and adopt the following resolution, unanimously carried upon roll call vote.
