

**TOWNSHIP OF GREENWICH
PLANNING/ZONING BOARD
REORGANIZATION MEETING
MARCH 4, 2013**

The Reorganization meeting was called to order by Mr. Rosenberger, Esq., Board Solicitor. Mr. Rosenberger swore in Mr. Reinhart, Mr. Hedges, Ms. Watson, Ms. Hunter and Ms. Garrison to the Planning/Zoning Board.

Those present were William Reinhart, Alan Hedges, Dean Rook, Doug Valente, Ken Sheppard, Michael Henry, Penelope Watson and Charlotte Hunter. Also present were: George Rosenberger, Solicitor and Lisa Garrison, Board Secretary. Absent: Joe Pointkowski and Bill Van Pelt.

At this time Nominations for Chairman were requested. Mr. Henry nominated Bill Van Pelt. It was stated that Mr. Van Pelt was adamant that he did not want the position. There being no second said nomination failed. Mr. Rook was nominated as Chairman on motion of Mr. Valente and seconded by Ms. Watson. Nominations were closed on motion of Mr. Hedges and seconded by Mr. Sheppard. Mr. Rook was then appointed Chairman with all in favor and none opposing said nomination.

Chairman Rook then called for nominations for the position of Vice Chair. Mr. Valente nominated Ms. Watson with said nomination seconded by Mr. Reinhart. Mr. Henry motioned to close said nominations with Mr. Sheppard seconding said motion. Ms. Watson was then appointed Vice-Chairperson with all in favor and none opposing said nomination.

Chairman Rook called for the setting of the meeting dates for the year 2013. On motion of Ms. Watson, seconded by Mr. Reinhart to set the meeting dates for the second Monday of the month at 7:30 p.m. with the exception of September to be set for the second Monday, unanimously carried. Said meeting dates will be published and posted.

Chairman Rook called for the Appointment of Solicitor. Mr. Rosenberger was nominated as Solicitor on motion of Mr. Henry and seconded by Mr. Reinhart. Mr. Sheppard motioned to close said nominations with Mr. Valente seconding said motion. Mr. Rosenberger was appointed as Board Solicitor with all in favor and none opposing said nomination.

Chairman Rook called for the Appointment of Board Secretary. Ms. Garrison was nominated as Board Secretary on motion of Mr. Reinhart and seconded by Ms. Watson. Mr. Valente motion to close said nominations with Mr. Sheppard seconding said motion. Ms. Garrison was appointed as Board Secretary with all in favor and none opposing said nomination.

Financial Disclosure Forms – Ms. Garrison explained to the Board a new process will be utilized this year with the forms being processed online.

On motion of Mr. Sheppard, seconded by Mr. Valente to adjourn the reorganization meeting, unanimously carried.
