RESOLUTION NO. 2-16-2022

APPROVING THE MUNICIPAL ALLIANCE STRATEGIC PLAN FOR FISCAL YEAR 2023 (JULY 1, 2022 – JUNE 30, 2023)

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey.

WHEREAS, The <u>Township</u> Committee of the <u>Township</u> of Greenwich, County of Cumberland, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, the <u>Township</u> Committee further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the <u>Township</u> Committee has applied for funding to the Governor's Council on Alcoholism and Drug Abuse through the County of Cumberland;

NOW, THEREFORE, BE IT RESOLVED by the <u>Township</u> of Greenwich, County of Cumberland, State of New Jersey hereby recognizes the following:

Ordinances:

PROPOSED ORDINANCE NO. 60-2022

2022 "CAP" ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, <u>N.J.S.A.</u> 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, <u>N.J.S.A.</u> 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Committee of the Township of Greenwich, in the County of Cumberland finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$3,947.25 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Greenwich, in the County of Cumberland, a majority of the full authorized membership of this governing body affirmatively concurring that, in the CY 2022 budget year, the final appropriations of the Township of Greenwich shall, in accordance with this ordinance and <u>N.J.S.A.</u> 40A:4-45.14, be increased by 3.5%, amounting to \$13,814.00, and that the CY 2022 municipal budget for the Township of Greenwich be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

On motion of Mayor Reinhart, seconded by Deputy Mayor Orr to approve the introduction of the foregoing proposed ordinance, unanimously carried upon roll call vote. Ayes: Orr, Werley, Reinhart Nays: None Abstain: None Absent: None

Unfinished Business:

Tennis Court - Ms. Fleetwood indicated the project can be financed through the ARPA money. Upon review and discussion it was determined that Ms. Fleetwood will further follow up with the State on the parameters of the funding.

Historic District - no change in status. Mr. Seeley will reach out to the Land Use Board to determine the status.

Old Stone School House - an extension was requested until June. Ms. Garrison indicated there may be a grant available for further funding.

Generator – Mayor Reinhart requested it be placed on the budget wish list. A request is to be made of the County to contribute for the ongoing maintenance cost as it is being utilized at the OEM building.

Wible Drive Reconstruction Project Easement - Mr. Seeley updated the Committee on the discussion being held with Mr. Dare. Deputy Mayor Orr indicated Mr. Dare's offer may o be feasible as the construction cost would increase and possibly kill the entire project as it would not fall within the budget. The Committee requested that Mr. Nardelli and Mr. Seeley respond to Mr. Dare.

Gas Tank Fire Department - Mayor Reinhart received two (2) quotes:

Woodruff - \$3,375 Ross Fogg - \$1,963.15 + \$200 for pump

After review and discussion, on motion of Mayor Reinhart, seconded by Deputy Mayor Orr to approve the quote of Ross Fogg not to exceed \$2,500.00, unanimously carried.

WHEREAS, the Township Committee is desirous of appointing Kim Fleetwood as Dog Registrar.

Land Use Board Appointments - The Township Committee has received names from the Land Use Board in consideration of appointments to fill vacancies in the alternate positions. After review and discussion the Committee has concurred that a letter of interest along with a resume is to be requested to fill vacancies on any Board/Commission or Committee. Ms. Garrison will reach out to the Land Use Board Secretary to advise.

Solicitor's Report:

Mr. Seeley presented his written report to the those present. He updated the Committee on COVID matters and eviction decisions and how these would affect the Township. The damage to the fire truck was determined at this time to be handled by the Fire Department as Mr. Seeley advised it may not be cost effective for him to pursue the matter. Fire Chief Charles Reinhart indicated he will be pursuing another company to complete any future testing of the truck.

Committee Comments:

Committeeman Werley raised concerns regarding a property maintenance issue on 940 Ye Greate Street. Deputy Mayor Orr also brought up the status of the property located at 92 Pier Rd. Ms. Garrison indicated she would contact Mr. DeSario. The prospect of a demolition or a tax lien assignment was also discussed regarding 92 Pier Rd. Ms. Garrison will contact the Tax Collector for the status of the tax lien.

Payment of Bills:

After review and discussion on motion by Mayor Reinhart, seconded by Deputy Mayor Orr to approve the bill list of December in the amount of \$63,686.00 and the February bill list in the amount of \$532,689.01, unanimously carried

Public Comment:

On motion of Mayor Reinhart, seconded by Deputy Mayor Orr to open the public comment. Fire Chief Charles Reinhart requested of the Committee to keep in mind the replacement of the diesel fuel tank at the Fire Department while preparing the 2022 budget. There being no public comment forthcoming on motion of Mayor Reinhart, seconded by Deputy Mayor Orr to close the public comment, unanimously carried.
